What is the Role of the Governors during the Inspection Process?

- The Lead Inspector will wish to meet with the Chair and as many Governors as possible. Inspectors increasingly want to also meet with the Trustees if you are within a MAT
- Inspectors will make judgements about the overall impact of governance on the school and its provision
- Documents about the work of Governors will be requested, especially the minutes of meetings
- All Governors are entitled to attend the feedback meeting at the end of the inspection and know the outcome as soon as possible. Recommended that this is clerked by the school.
- > Outcomes must be kept confidential until the final inspection report is published



Ofsted Expectations, Evaluation and Governance Inspection Handbook September 2022

Line 313.

The leadership and management judgement is about how leaders, managers and those responsible for governance ensure that the education that the school provides has a **positive impact** on all its pupils. 320. Inspectors will seek evidence of the impact of those responsible for governance.

321. In a maintained school, those responsible for governance are the school governors. In a stand-alone academy, it is the trustees.


Inspectors will explore how governors carry out each of the 3 core functions For example, the clarity of the school's vision, ethos and strategic direction will have a significant impact on the decisions that leaders make about the curriculum.

Inspectors will consider whether **the work of governors** in this respect is supporting the school to provide a high-quality education for its pupils.





THE THREE CORE FUNCTIONS OF GOVERNANCE







Does the Governing Board Understand the Roles and Responsibilities of Clerking?

Strategic leadership that sets and champions vision, ethos and strategy.

Professional clerking supports and challenges the chair to **ensure the board focuses** on **strategic** rather than **operational** decisions and flags up where the board is overstepping or deviating from its role.

This enables the board to focus on its strategic role and to exercise its functions effectively and confidently.

Accountability that drives up educational standards and financial performance.

- Professional clerking plays a crucial role in supporting the board to hold executive leaders to account.
- It provides guidance to the chair and board to help them identify the information they require and the questions they should ask of senior leaders.
- It works with senior leaders to provide the information and data that the board requires about education standards and financial performance in a timely manner.

Linking the 3 core Functions of Governance with Clerking Competencies





Strategic Versus Operational Roles and Responsibilities are these Understood?

- **Parent governors** are not as a spokesperson for the views of parents. They are the same as any other governor on the board, providing a *'parental viewpoint'* i.e., representative parents rather than representatives of parents.
- Co-opted governors act in the best interests of the school and wider community, but should not be required by others, such as the appointing board or community, to take a particular stance on issues discussed at board meetings.
- LA governor is a representative of the local authority. The role of a LA governor is the same as any other governor, including providing a 'LA viewpoint'
- **Staff governor** is the same as any other governor, strategic leadership and holding the Headteacher to account, but also includes providing a 'staff viewpoint'.



Statutory Compliance





•Compliance with statutory and contractual requirements

•Professional clerking provides knowledgeable and confident support to the board to ensure compliance (and an understanding of the consequences of non- compliance) with the relevant legal frameworks, contractual obligations and governance requirements of the organisation.

This includes ensuring that proper processes are followed, decisions are correctly made,
statutory policies are in place and that a record of policies; along with copies of policies and procedural documents approved by the board are maintained and accessible as required.

Question-How do governors access school information and documents? What systems are in place?

Boards responsibilities for safeguarding

(EIF) Governance Line 328.

Governors are also expected to exercise strategic oversight of all aspects of safeguarding.

When inspectors consider whether governors are fulfilling this responsibility, they are not expected to construct or review a list of duties.

- Leadership: Boards must ensure a designated safeguarding lead has been appointed from the senior leadership team to manage safeguarding issues. A Lead Safeguarding Governor must be appointed.
- Policy setting: Boards must ensure there is an effective child protection policy describing the school's procedures and how it works with other agencies. It should be updated after the publication of KCSIE.
- Monitoring: there should be regular reporting to Governors. Boards should consider safeguarding and child protection issues at a strategic level and understand any local community issues.



Safeguarding and Governors Accountability

Evidence that this has been completed

There is a requirement for all board members to receive regular training about safeguarding in order for them to have the knowledge and information needed to perform their functions, understand their responsibilities and assure themselves that the school's safeguarding arrangements are robust. (KCSIE September 2022)

Example question for governors could be;

How can governors assure themselves that the child protection policy is being followed and delivered at the point of need?



Impact of Effective Governance







What impact should governors have?

- We use our <u>knowledge of our school</u> to <u>direct and monitor school</u> <u>improvement</u> so that our school continues to improve and provide the best possible education and care for our pupils
- We ensure adults in our school are <u>held to account</u> to deliver the best possible education and care for our children
- We ensure we <u>maximise the impact of the funding</u> available to us





Knowing your school's context



- 1. Do governors know their school communities?
- 2. Is this reflected and evidenced in governance documentation?





Evaluation to monitor and improve the quality and impact of governance


- Professional clerking provides an audit trail to contribute to any review of the effectiveness of the board's governance.
- This includes comprehensive minutes of meetings that record the board's discussions and decisions, and records of individuals' attendance and the actions that have been taken to address any skills gaps.



Minutes of Meetings

- 1. Do the minutes of meetings highlight questions asked by governors?
- 2. Are actions listed and followed up?
- 3. Do governors list three key decisions they have made during the meeting that will have an impact on pupil outcomes?

A Balance of Support and Challenge








The Curriculum

Governing Boards are responsible for ensuring that their School offers a wide and varied curriculum.


Example Question for governors could be – How do you know that your school delivers this?

Five Steps to Support Governors in the Inspection Process







Gathering the Evidence of Effective Governance Practice

- 1. Support and prepare for all governors to speak not just the Chair
- 2. Prepare a pack of key documents to refer to and evidence answers to questions

For example; discussing monitoring activities and example reports, roles and responsibilities, and recent minutes of meetings to demonstrate holding to account and the impact of governance

3. Prepare a list of things that governors want to share with the inspector. **Examples of good practice**. It also provides a checklist to refer to during the conversation

4. The pack can provide answers and link to **examples and evidence** if appropriate.

5. The pack to be left with **the inspector which supports their role** in the process

- **2.** Safeguarding documents including a current copy of KCSiE
- 3. SEF, Context, evaluation of previous years outcomes
- 4. School Development Plan

- 6. Minutes of meetings and most recent FGB/LGB meeting
- 7. Governors Training record
- 8. FGB/LGB Monitoring Schedule
- 9. Monitoring reports
- **10.Delegated Roles and responsibilities**
